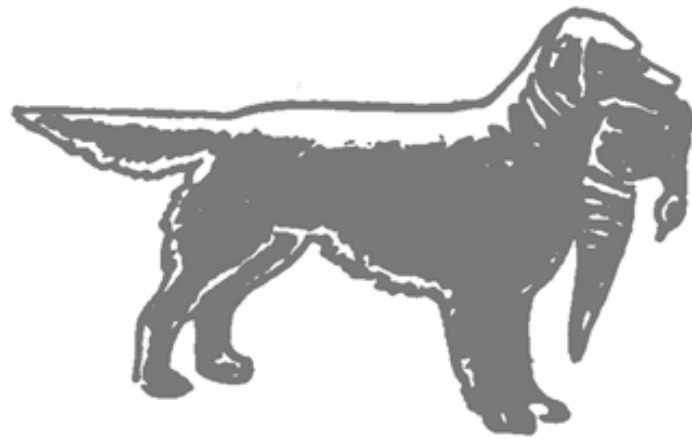

To have attended a seminar given by a Kennel Club Accredited Trainer on Conformation and Movement.

To have attended a Points of the Dog Assessment conducted by a Kennel Club Accredited Trainer and passed the assessment.
